







## A Letter from the CEO

Twenty-five years ago, the organizations that came together to form Covenant Health had a mission: to serve the community by improving the quality of life through better health. As we worked to fulfill that mission over the years, a vision evolved to make Covenant Health the first and best choice for health care.

Today, we have a lot to celebrate. A quick overview:

We have approximately 2 million patient encounters annually in our 23-county service area.

About half of all major medical procedures in our area are performed at Covenant Health facilities.

We're the largest employer in the region, with 10,000 employees, and we've been named a "Best Employer" seven times by Forbes.

But numbers alone don't tell the full story. We've invested in our facilities and services so that people throughout our region have access to excellent medical care. We've invested in our data management capabilities and innovative virtual urgent care technology. In our facilities, virtual technology supports our caregivers in critical care, psychiatry and other areas.

As we look ahead, we're implementing long-term strategies to continue caring for our neighbors, including:

Addition of proton therapy to our cancer care services.

A new behavioral health hospital in partnership with Acadia Healthcare.

A new Patricia Neal Rehabilitation Hospital in partnership with Encompass Health and renovations to our downtown Patricia Neal Rehabilitation Center.

New outpatient facilities in South Knoxville and Morristown.

We're also educating the healthcare professionals of tomorrow:

We recently welcomed the largest class of medical students from Lincoln Memorial University to clinical rotations at our hospitals.

We announced a partnership with Roane State Community College and Tennessee College of Applied Technology, with a new campus dedicated to training future healthcare professionals to be located near Parkwest Medical Center.

We're announcing a new family practice medical residency program at Methodist Medical Center.

Healthcare is currently facing many challenges, but
Covenant Health is financially strong and continues to
invest in the future. Our mission and vision keep us focused
on our Pledge of Excellence: Patients always come first,
excellence in everything we do, and making Covenant
Health the first and best choice.

Our past achievements and our future initiatives are possible because of the contributions of those who came before us, and because of our dedicated volunteer board, our health system leaders, employees, physicians, volunteers and donors. We're especially grateful for the trust and confidence our communities have placed in Covenant Health. 

## Virtual Care in the Hospital

Virtual services at our hospitals offer advanced care for complex medical conditions and can help smaller communities through remote access to specialized Covenant Health resources. Our physicians use telehealth technology to monitor a patient's condition remotely or consult with other medical professionals regarding the best course of treatment. Virtual care may enhance hospital services in cardiology, critical care, nephrology, newborn nursery, psychiatry, stroke and neurology.

#### Tele-ICU

Covenant Health is the first healthcare system in East
Tennessee to provide tele-ICU as an extra layer of care for
critically ill patients at all our member hospitals. Our tele-ICU
medical providers have advanced training in critical care and
are available for round-the-clock consultation and monitoring
of vital signs, labs and overall health. The tele-ICU team works
virtually alongside our hospital staff, anticipating medical
needs before they become urgent.

#### Access to Care Wherever You Are

Covenant Health's virtual care opportunities continued to expand in 2021, with healthcare services available to our patients via computer or mobile device. Our virtual care options are designed for convenience, safety and access to care. Covenant Health offers scheduled appointments with physicians and recently launched Virtual Urgent Care, with emergency-trained physicians available anywhere in East Tennessee.

#### East Tennessee Behavioral Health

#### Specialized services in a holistic environment

To address the growing need for mental health services in our region, Covenant Health has partnered with Acadia Healthcare to construct a new 90-bed behavioral health hospital. The facility continues our legacy of behavioral services and enhances existing resources at Covenant Health and other local organizations.

With the ability to add additional beds to meet future demand, the hospital will serve adolescents, adults and seniors with mental health and co-occurring disorders.

Construction continued throughout 2021, and East Tennessee Behavioral Health opened on Aug. 8th, 2022.

# Covenant Health adds proton therapy to our comprehensive cancer services

In mid-2022, Covenant Health announced the purchase of Provision CARES Proton Therapy Center in Knoxville, adding a new treatment option to Thompson Cancer Survival Center, the health system's robust oncology service line.

Proton therapy is an advanced form of radiation therapy that uses beams of high-energy protons to treat various forms of cancer while protecting nearby healthy tissue and vital organs from unnecessary radiation.

Thompson Proton Center is one of just 40 proton therapy centers in the U.S. Patients across our region can now receive proton therapy as part of Covenant Health's umbrella of cancer services offered through Thompson Cancer Survival Center locations and Covenant Health's cancer care network.

# New outpatient facilities underway in South Knoxville and Morristown

Construction began in 2021 on a \$20 million outpatient facility in South Knoxville. The facility has more than 36,000 square feet and will include an urgent care area with extended hours, a clinic for primary care and other medical subspecialties, a diagnostic center with laboratory and imaging services, and areas for physical rehabilitation and education.

South Knoxville is rapidly becoming a destination community, with recent expansions in residential growth, thriving businesses and recreation areas. The new project will provide a variety of

needed health services in a convenient location that's easily accessible for people in South Knoxville and Seymour. It will also have access to Covenant Health's network of services when patients need medical care. The facility is scheduled to open in late 2023.

In 2021, one of Covenant Health's member hospitals, Morristown-Hamblen Healthcare System, began building a \$37-million outpatient facility near a convenient access point for Interstate 81. The 50,000-square-foot facility will include a free-standing emergency department and diagnostic center, as well as physician offices, and will be known as Morristown-Hamblen West. The project is scheduled to be completed in 2023.



Total Operating Revenue


